### WHY DO YOU NEED A WILL?



Knowing the process of writing a Will can sometimes be hard to understand, but that's why we're here to help. It all starts with your estate. Your estate is what you leave behind when you're gone. This is made up of everything you own, like money, property and personal belongings.

Your estate also includes your share of things that you own with other people. Anything you owe, for example, **a mortgage, is** taken away from the total value of your estate.

A Will is a legally binding document that sets out how your estate should be distributed. It's where you can say **who you want your belongings to go to and who should look after your children**. You can also include your wishes of what type of funeral you would like and it's where you can request how your gift is used.

Having an up to date, professionally written Will is the **best way to** ensure your wishes are followed.

If you die without a Will, you're 'interstate' and the law decides who inherits your estate, which may not be what you want to happen.

### That's why making your Will is incredibly important.

### **EASY STEPS** TO MAKING A WILL...

Getting your Will written needn't be as daunting as you may at first think. We recommend you seek the services of a solicitor to have your Will written. Writing your own, even with a Will pack, can be risky because probate law, inheritance tax and the language used are not always straightforward.



When writing your Will, it's important to think about the things that matter most to you. Whether this is family or friends, think about who you want to remember and the type of gifts that you want to leave them. Once you've looked after your loved ones you may also want to consider supporting causes that mean a lot to you.

Gifts in Wills left to charities are incredibly important. If it wasn't for these gifts, we wouldn't be able to support anywhere near as many people as we currently do.

#### The right wording to include in your Will

If you decide to include a gift in your Will to Lancashire Cricket Foundation, please use the recommended form of wording given in one of the following paragraphs:

#### **Residuary gift**

I give XX% / the rest of my estate after payment of funeral and testamentary expenses and debts to my Executor(s) in trust for The Lancashire Cricket Foundation, Guarantee (6393483) and a Registered Charity (1121855), absolutely for its general charitable purposes and I direct that the receipt of the Director General or other proper officer for the time being of the said Society shall be a sufficient discharge for the said monies.

#### **Pecuniary gift**

I give to The Lancashire Cricket Foundation, Guarantee (6393483) and a Registered Charity (1121855), the sum of XXXXX pounds, £XX free of Inheritance Tax for its general charitable purposes and I direct that the receipt of the Director General or other proper officer for the time being of the said Society shall be a sufficient discharge for the said monies.



#### There's normally no Inheritance Tax to pay if either:

- the value of your estate is **below the £325,000 threshold**
- you leave everything above the £325,000 threshold to your spouse, civil partner, a charity or a community amateur sports club.

If your estate's value is below the threshold you'll still need to report it to HMRC.

If you give away your home to your children (including adopted, foster or stepchildren) or grandchildren, your threshold can increase to **£475,000**.

If you're married or in a civil partnership and your estate is worth less than your threshold, any unused threshold can be added to your partner's threshold when you die. **This means their threshold can be as much as £950,000**.

### **Inheritance Tax rates**

The standard Inheritance Tax rate is **40%**. It's only charged on the part of your estate that's above the threshold. For example, if your estate is worth **£500,000** and your tax free threshold is **£325,000**, the Inheritance Tax charged will be **40% of £175,000 (£500,000 minus £325,000)**.

### How can I reduce the Inheritance Tax on my estate?

Leaving a gift to a charity will **reduce how much tax you owe**, with the value deducted from your estate before any tax liability is calculated. The estate can pay Inheritance Tax at a reduced rate of 36% on some assets if you leave 10% or more of the 'net value' to charity in your will.

Inheritance Tax can be very complicated so we really recommend speaking to someone qualified to advise you about estate planning if you think you may be liable for tax.
